## Attention!

In connection with the entry into force of the Federal Law № 357-FZ of 14.07.2022:

All foreign citizens (except citizens of the Republic of Belarus and citizens with the status of temporary residence permit or residence permit), who entered the territory of the Russian Federation before 31.12.2021, are required to undergo fingerprinting and medical examination until 10.01.2023.

All **foreign citizens** (except for citizens of the Republic of Belarus and citizens having the status of temporary residence permit or residence permit) arriving in the Russian Federation since **29.12.2021** must undergo mandatory fingerprinting, photographing and medical examination (in accordance with the Federal Law of the Russian Federation №274-FZ of 01.07.2021):

- > Students, postgraduate students, trainees within 90 days from the moment of entry into the Russian Federation.
- Foreign teachers within 30 days from the moment of entry into the Russian Federation.

## The order of passing:

- 1. Medical examination.
- 2. Receiving the results of the medical examination.
- 3. Photographing, fingerprinting.
- 4. Obtaining a certificate.

To undergo mandatory state fingerprint registration, photographing and medical examination, foreign nationals must apply in person at:

IMPORTANT: you must bring your passport, a notarized translation of your passport, a migration card and a valid registration.

According to the results, the foreign citizen receives a document confirming the passing of fingerprint registration and photographing and a certificate of acceptance of medical documents.

On the cost of services at 10-12 Krasnogo Tekstilshchika Str.: medical examination - **4900 rubles** / **5** working days, a photograph - **350** rubles, dactyloscopy - free.

**ATTENTION**: The medical examination can be performed at the following address: St. Petersburg, 10-12 Krasnogo Tekstilshchika Str., lit. B (entrance 2 from the courtyard), or at any medical institution listed in Appendix 1. Medical documents are valid for 12 months. After this period, foreign citizens must apply again within 30 calendar days to undergo a medical examination.

The period of temporary stay in the Russian Federation of foreign citizens is reduced if they fail to comply with the obligation to undergo mandatory state fingerprinting registration, photographing and (or) medical examination.

If as a result of a medical examination, the fact of the use of narcotic drugs or psychotropic substances without a doctor's prescription or new potentially dangerous psychoactive substances is established, or it is established that these foreign nationals suffer from a disease caused by human immunodeficiency virus (HIV infection), the decision on undesirability of stay (residence) in the Russian Federation or the decision on non-admission to the Russian Federation is made.
