

Consent to personal data processing

1. Terms and definitions

Website – the website located on the internet having the address with the domain name and address - .spbstu.ru

Contest – this is the contest of the website user agree for personal data processing

Operator – Federal State Autonomous Educational Institution of Higher Education ‘Peter the Great St. Petersburg Polytechnic University’ located at the address: Polytechnicheskaya 29, St. Petersburg, Russia, 195251; OGRN (Primary State Registration Number): 1027802505279, INN (TIN – Tax Identification Number) 7804040077.

User of the website – the subject of personal data or (in case of inability to act) his/her legal representative to provide the Operator with the own personal data or the personal data of the unable person by doing a range of operating actions in a corresponding part of the Website user interface.

Request – a message made by the User of the Website and addressed to the Operator which is forwarded by the user of the website by doing a range of operating actions in a corresponding part of the Website user interface. The terms which are not revealed in this section of the Consent to personal data processing shall be read as the notions stated in the Federal Law dd. 27.07.2006 № 152-ФЗ (FL) ‘About Personal Data’.

2. Conditions for the website users to provide consent

This is to certify that the User of the Website who put a tick in the check-box in a corresponding part of the Website user interface near the inscription ‘By putting a tick in this check-box You give the consent for personal data processing, voluntary provides the Operator with an accurate, informative and meaningful Contest acting at liberty and pursuing own interests under the following conditions:’

User of the website:

confirms that all the data specified herein belong to him/her personally, confirms and admits that he/she has fully and carefully read the Consent and its requirements for processing of his or her personal data specified in the gaps of the online forms on the website, agrees with the conditions of personal data processing without any reservations and constraints.

The Operator of the Website is not responsible if personal information placed by the User on the Website has been used (legally or illegally) by third parties including its reproduction and distribution made by all means.

Purposes of personal data processing:

the Operator shall fulfill a Request under which the User of the Website provides personal data.

List of personal data to be processed after the Contest has been given:

The Contest for processing that scope of data which are provided by the User while completing the gaps of the Request is to be given to the Operator by the User of the Website.

The list of the actions to process personal data under the Contest given:

to collect, record, organize, accumulate, store, clarify (update and change), import, use, impersonalize, ban and remove personal data.

General description of the Operator's methods to process personal data:

non-automated processing of personal data, automated processing of personal data with or without transfer via the Internet, combined processing of personal data.

3. Procedure to suspend the Contest

The Contest is valid within one calendar year and can be suspended in case the User of the Website forwards to the Operator a corresponding claim to the address specifies herein: opit-media@spbstu.ru. The contest can be considered to be suspended during 7 (seven) working days upon the date when the claim was received by the Operator.

4. Final Provisions

The new version of the Contest shall come into force after the new version is placed on the website unless otherwise provide by the new version of the Contest.
