On the activities to prevent the spread of coronavirus infection

In connection with the decision of the Directorate of the Federal Service for the Surveillance in the Sphere of Consumer's Rights Protection and Public Welfare in St. Petersburg on the introduction of restrictive measures at dormitory No. 13 at 30, Grazhdansky Ave. (Resolution No. 78-00-09 / 72-13504-2020)

I HEREBY ORDER:

- 1. To organize an observator in the building of dormitory No. 13 at #30, Grazhdansky Ave., in strict accordance with the Recommendations for organizing operation of the observatory for people arriving from an epidemically unfavorable areas regarding the new coronavirus infection, which is presented in an appendix to the letter of Rospotrebnadzor dated 23.03.2020 02 / 4708-2020-27.
- 2. To prohibit the entrance and exit of residents of the dormitory as 22.05.2020 for a period of 14 days.
- 3. The general management of life support for residents of dormitory No. 13 shall be assigned to the SPbPU operational headquarters (head V.V. Glukhov).
 - 4. To form a dormitory life-support coordination group consisting of:
 - Director of the Campus A.A. Schneider
 - Head of the "On Grazhdansky Avenue" dormitory complex A.N. Nikulin
 - Head of dormitory No. 13 N.Yu. Kurgut
 - Deputy Director of the HS IEP P.S. Nedelko
 - Commandant of dormitory No. 13 I.N. Melekhova
 - Senior administrator of dormitory No. 13. V.V. Petrov.
 - 5. Vice-rector for security A.V. Ivanov shall:
 - Organize round-the-clock security at dormitory No. 13
 - Keep persons not involved in its work off the territory of the observatory
 - Ban entry and exit of persons living in dormitory No. 13
 - Organize patrolling of the territory adjacent to dormitory No. 13
- Ensure interaction with the district administration, Ministry of Emergencies and Ministry of Internal Affairs during the epidemiological measures.

- 6. Director of the Department of Logistics and Social Security Z.V. Naumova shall provide the necessary facilities for disinfection, personal protection and sanitary cleaning for staff and residents of dormitory No. 13.
 - 7. Vice-rector for international activities Arsenyev D.G. shall
- Organize information and interaction with embassies, consulates and fraternities
- Provide measures to resolve issues related to migration registration of students who stay in quarantine
- Organize interaction with foreign students who are in quarantine to inform them about the restrictions introduced and the support provided.
- 8. The directors of the institutes shall adjust the schedules of the educational process, conducting intermediate and final certification for students living in dormitory No. 13 with the account of the restrictions.
 - 9. Director of the Campus A.A. Schneider shall provide for:
 - Organization of a sanitary zone on the 1st floor of the dormitory
 - Food delivery to residents of the dormitory
 - Regular measurement of temperature of all residents (three times a day)
 - Regular cleaning with the use of specified disinfectants
 - Restriction on the movements of dormitory residents
- In conjunction with District Clinic number 112 and Clinic number 76 (as agreed), continuous medical supervision and examination of those in the dormitory and journaling the observatory.
- 10. Vice-rector for Economics M.A. Grekov shall organize waste collection from dormitory No. 13 in compliance with the necessary sanitary requirements.
- 11. Vice-rector for Youth Affairs M.A. Pasholikov shall organize the activities of a group of volunteers and their interaction with students who are in quarantine to provide the students with food and essentials.
- 12. Vice-rector for Economics and Finance A.V. Rechinsky shall provide funding for livelihood of the residents of dormitory No. 13.
- 13. Chief of the Operational Command Unit V.V. Glukhov shall organize constant monitoring of the condition, providing food and household materials to residents of dormitory No. 13.
 - 14. I shall personally supervise the implementation of the order.
