

## **Consent to the processing of personal data**

I hereby, in fulfillment of the requirements of the Federal Law of 27.07.2006 No. 152-FZ “On Personal Data”, give my consent to the Federal State Autonomous Educational Institution of Higher Education “Peter the Great St. Petersburg Polytechnic University”, address: 195251, St. Petersburg, the inner terr., Akademicheskoye city municipal district, 29 Polytechnicheskaya Str., let. B. (hereinafter - SPbPU) to process my personal data specified by filling in the web form on the website of SPbPU, with the following conditions:

1. Consent is given for processing of the following personal data: surname, first name, patronymic; telephone number (home/mobile); e-mail; user data (location information, type and version of OS, type and version of browser, type of device and its screen resolution; source from where the user came to the site; from what site or advertising; language of OS and browser; which pages the user opens and which buttons the user clicks on; IP address); data about me that will become known in the course of execution of contracts (in case of conclusion of a contract with me); data about me that will become known in the course of execution of contracts (in case of conclusion of a contract with me); data about me that will become known in the course of execution of contracts (in case of conclusion of a contract with me).

2. Personal data is not publicly available.

3. Personal data may be processed by means of automation and/or without means of automation in accordance with the current legislation of the Russian Federation.

4. The purpose of personal data processing: providing services to website users for the purpose of providing educational services to SPbPU, consulting on various issues, conducting surveys and questionnaires, organizing the sending of newsletters (mailings), as well as analyzing the user’s actions on the website.

5. The basis for processing personal data is Article 24 of the Constitution of the Russian Federation, Article 6 of Federal Law No. 152-FZ “On Personal Data”, as well as this Consent for Personal Data Processing.

6. During the processing of personal data the following actions will be performed: collection, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transfer (distribution, provision, access), blocking, deletion, destruction.

7. I am familiarized (a) with the fact that:

- This Consent to the processing of my personal data is valid for 20 (twenty) years or until the moment of termination of personal data processing and may be revoked by me by sending a written application to SPbPU. The date of revocation shall be the day following the day of delivery to SPbPU of the written application for revocation of the Website User’s Consent to the processing of personal data.

- I have the right to access my personal data, demand clarification (update, change) of my personal data, as well as deletion and destruction of my personal data in case of their processing by SPbPU that violates my legal rights and interests and the laws of the Russian Federation.

- In case of withdrawal of the Consent for processing of personal data, SPbPU has the right to continue processing of personal data without my consent if there are grounds specified in paragraphs 2.11 of Part 1 of Article 6, Part 2 of Article 10 and Part 2 of Article 11 of Federal Law No152-FZ “On Personal Data” dated 27.07.2006.

8. By this Consent I confirm that I am the subject of the provided personal data, as well as confirm the reliability of the provided data.
